Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, raised 9ct white gold & diamond set, cluster style dress ring, of cast construction. Plain, narrow, low half round, tapered band, measures 1.74mm width (at base) x 1.15mm depth, with curved underrail.

Feature, "cluster style" ring, with shoulder stones. Comprising, a raised square shaped setting to center housing sixteen single cut diamonds, grouped, bead set. Drops to a surround, containing twenty four baguette cut diamonds, claw set. The extended shoulders, of the band taper up to the top. Each shoulde contains six single cut diamonds, bead set.



Polished finish, stamped "375 JP02" - acid tested as 9 carat gold. Finger size = Q.

The ring contains;

Twenty Eight bead set single cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 0.90mm (average diameter)

Total Weight = 0.14ct (estimated - see NOTE below).

Twenty Four claw set baguette diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.

Average dimensions = 1.60mm (L) x 0.80mm (W) x 0.58mm (D-estimated)

Total Weight = 0.16ct (estimated - see NOTE below).

Total Item Weight = 2.80 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 2.74 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
