Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, gem set, oval hinged bangle, of hand-assembled construction.

Feature one row of twenty-four round brilliant cut diamonds, spanning across the top of the front panel. The diamonds vary slightly in size, and are channel set. Rhodium plating to the diamond setting areas. The bangle is finished with a box clasp, and two figure 8 safety catches.

Bangle dimensions = 70.00mm (ave. length) x 3.69mm (ave. width) x 1.99mm (ave. depth).

Polished finish.

Stamped '18K 750 illegible marks' - acid tested as 18 carat gold.

The bangle contains:

Twenty Four channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "yellow tint".

Dimensions = 2.25mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.43mm(Dia) x 1.48mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 21.08 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 20.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar bangle employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
