Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct white gold, gem set necklet.

Feature hollow, open back, rectangular-shape pendant design, housing two Princess cut diamond, end set. Articulated from a plain, tapering bail assembly.

The chain being of a 'box' type linkage design, having a small 'bolt' ring type clasp attached.

Polished finish.

Stamped '750 CG' (on pendant), '750 ITALY THL *60TV* 750' (on chain) - acid tested as 18 carat gold.

Pendant dimensions = 25.00mm (length including clasp) x 5.00mm (width) x 2.96mm (depth).
Chain dimensions = 45.00cm (length including clasp) x 0.93mm (width).

The necklet contains:

Two end set Princess cut diamonds, clarity 'Vs', colour 'G'.

Dimensions (average) = 2.20mm(L) x 2.20mm(W) x 1.54mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 5.60 grams

Total Gemstone Weight = 0.14ct

Total Metal Weight = 2.57 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
