Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, multistone, gem set ring, of cast construction.

Plain, wide, tapered band of 3.97mm width (at base) x 0.73mm depth, with hollow top and shoulders, and open back settings.

Feature raised dome top with railed edge, housing three round cut and faceted natural sapphires, largest to centre, star set. All secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Finger size is P.

The ring contains:

Three star set round cut and faceted natural sapphires, colour is "dark blue".

Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 5%(Bulge) (smallest)

Dimensions = 4.00mm(Dia) x 2.44mm(D-estimated) x 5%(Bulge) (largest)

Total Weight = 0.52ct (estimated - see NOTE below)

Total Item Weight = 4.23 grams

Total Gemstone Weight = 0.52ct

Total Metal Weight = 4.13 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
