Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and rhodium plated, multistone ring, of cast construction.

Plain, narrow, low half round band of 3.24mm width (at base) x 1.03mm depth, with open back settings, and a cut out curved underrail.

Feature one central row of seven round brilliant cut diamonds, spanning across the top of the band, claw set. There are two outer rows each housing fifteen round brilliant cut diamonds, channel set. The diamonds graduate in size, largest to the centre. The settings are secured between the tapering shoulders, of the plain and polished band. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped '14K michael hill 1.50TDW' - acid tested as 14 carat gold.

Ring size: N.

The ring contains:

- Thirty Seven claw and channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to J" (mixed).
Dimensions = 1.40mm(Dia) x 0.85mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 3.45mm(Dia) x 2.10mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 1.50ct (estimated - see NOTE below)

Total Item Weight = 7.87 grams

Total Gemstone Weight = 1.50ct

Total Metal Weight = 7.57 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
