One, 3pce set, hand-assembled 18ct yellow gold, hollow bangles.

Feature; '3pce set'. Comprising, each bangle, half round profile, having a Grecian key design to the outer circumference of each bangle. The inner band having a plain centre strip & stippled finished to the sides.

The bangle are of hollow construction, secured with a fine wrap around sleeve (grouped together)

Polished finish.

Stamped "K18" - acid tested as 18 carat gold.

Bangle each wrist dimensions = 68.00mm (inner diameter) x 3.50mm (W) x 2.07mm (depth).

Bangle combined 11.51mm (width).

Total Item Weight = 12.30 grams.
