Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.99mm width (at base) x 1.10mm depth, with a hollow top and shoulders, and open back settings.

Feature three rows housing a total of fifty-five round brilliant cut diamonds, graduating in size, and pave set. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '10K MHJ' - acid tested as approximately 10 carat gold.

Ring size: J.

The ring contains:

Fifty Five pave set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.46mm(Dia) x 0.89mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.66ct (estimated - see NOTE below)

Total Item Weight = 1.93 grams

Total Gemstone Weight = 0.66ct

Total Metal Weight = 1.80 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
