Valuation for Traditional Retail Insurance Replacement

One, 14ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band 3.24mm width (at base) x 1.97mm depth.

Feature one row of twelve round brilliant cut diamonds, alternating with twelve round natural sapphires, claw set. The band is embellished with millegrain detail, and an engraved pattern. The settings are secured between the shoulders of the plain and polished band.



Polished finish.

Stamped '14K' - acid tested as 14 carat gold.

Ring size: M.

The ring contains:

Twelve claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.54ct (estimated - see NOTE below)

Twelve claw set round natural sapphires, colour is "pink".

Dimensions (average) = 2.30mm(Dia) x 1.40mm(D-estimated)

Total Weight = 0.60ct (estimated - see NOTE below)

Total Item Weight = 4.70 grams Total Gemstone Weight = 1.14ct Total Metal Weight = 4.47 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones as very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
