Feature: " rounded hollow curb link chain, with crescent end sections & a jumbo size bolt ring closure, attached.

Suspended from the necklet a puff heart-shaped padlock charm.

Polished finish.

Stamped "375, 9ct" - acid tested as 9 carat gold.

Necklet dimensions = 53.00cm (total length) x 10.21mm (width) x 5.50mm (depth).

Charm/Padlock dimensions = 30.00mm (length) x 19.00mm (width) x 10.80mm (depth).

Total Item Weight = 70.20 grams.
