Valuation for Traditional Retail Insurance Replacement

Item 1

One, single row, graduated strand, of cultured pearls, & 18ct white gold, diamond set, Princess length necklace.

Feature ; one graduated cultured pearl strand, attached, lady's hand-assembled raised 18ct white gold, open oval shaped clasp, contains four round brilliant cut diamonds, claw set, to centre.

Clasp: , polished finish, stamped "750" - acid tested as 18 carat gold.
Clasp dimensions = 24.32mm (length) x 11.48mm (width) x 7.33mm (depth).

Strand contains;

Eighty Three drilled round cultured white/pink pearls, lustre is "High", blemish is "Few blemishes-Lightly spotted", very good matching.

Dimensions = 3.99mm (average diameter) (smallest)
Dimensions = 8.01mm (average diameter) (largest)
(estimated - see NOTE below).

Four claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H "(mixed), medium cut quality.

Dimensions = 2.32mm (average diameter) x 1.42mm (D-estimated) (smallest)
Dimensions = 2.42mm (average diameter) x 1.48mm (D-estimated) (largest)
Total Weight = 0.16ct (estimated - see NOTE below).

Total Item Weight = 20.70 grams, Total Gemstone Weight = 0.16ct, Total Metal Weight = 5.00 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar strand employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
