Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct yellow gold and rhodium plated, multistone, gem set ring. Plain, narrow, tapered band of 2.20mm in width (at base) x 0.83mm depth, with open back settings.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Secured between the 'wrap-around' style shoulders of the yellow gold plain and polished band, channel set with a total of twenty-seven tapered baguette cut diamonds, tapering in size.

Polished finish - stamped '18K 750' - acid tested as 18 carat gold. Finger size is F.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si', colour 'H'.
Dimensions = 4.34mm(Dia) x 2.65mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.30ct (estimated - see NOTE below)

Twenty Seven channel set tapered baguette cut diamonds, clarity 'Vs & Si' (mixed), colour 'H to J' (mixed).
Dimensions = 2.10mm(L) x 1.05mm(W) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 3.75mm(L) x 1.45mm(W) x 1.00mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.70ct (estimated - see NOTE below)

Total Item Weight = 4.33 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 4.13 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
