## Valuation for Traditional Retail Insurance Replacement

### Item 1

One pair of, 9ct white gold, diamond set, multistone, stud earrings, of hand-assembled construction.

Feature central round top plate, housing seven round brilliant cut diamonds, bead set. Surrounding is two floating rows, with a total of one hundred single cut diamonds, bead set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 10.53mm (ave. length) x 10.53mm (ave. width) x 4.00mm (ave. depth).

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

The earrings contain:

Fourteen claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.14ct (estimated - see NOTE below)

One Hundred claw set single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to K" (mixed).

Dimensions = 0.95mm (diameter) (smallest)

Dimensions = 1.05mm (diameter) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)



Total Item Weight = 3.23 grams Total Gemstone Weight = 0.64ct Total Metal Weight = 3.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
