Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand finished raised, 18ct yellow gold & diamond set, solitaire ring. Plain, wide, half round, tapered band, measures 3.53mm width (at base) x 1.10mm depth, with cut-out underrail, open back setting, underneath.

Feature, "solitaire style ring design. Comprising, a raised rub-over setting to centre, houses one round brilliant cut diamond, rub-over set. The extended shoulders, of the band tapers up to three roll-over collar terminations, to both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = M.

The ring contains;

One rub-over set round brilliant cut diamond, clarity is "Si2", colour is "G", medium cut quality.

Dimensions = 4.73mm (average diameter) x 3.49mm (D-estimated)

Total Weight = 0.50ct (estimated - see NOTE below).



Total Item Weight = 5.88 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 5.78 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
