Valuation for Traditional Retail Insurance Replacement

One, pair of lady's hand crafted raised sterling silver & diamond set, drop earrings.

Feature, "Fleur-de-lis" style drop earrings. Comprising, each contains ten round brilliant cut diamonds, claw set, an acrtyculated drop, both with threaded posts and butterflies, fitted & attached.

Polished finish, stamped "C76, C76" - acid tested & x-rayed as silver

Earring dimensions = 17.00mm (length) x 10.00mm (width) x 5.00mm (depth).

The earrings contain:

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.

Dimensions = 2.50mm (average diameter) x 1.53mm (D-estimated)

Total Weight = 0.12ct (estimated - see NOTE below).

Twelve claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.

Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (smallest)

Dimensions = 2.10mm (average diameter) x 1.28mm (D-estimated) (largest)

Total Weight = 0.36ct (estimated - see NOTE below).

Six claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)

Total Weight = 0.08ct (estimated - see NOTE below).

Total Item Weight = 4.00 grams, Total Gemstone Weight = 0.56ct, Total Metal Weight = 3.89 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar pair of earrings, employing similar materials and techniques being for a retail insurance purpose only.
