Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 9ct yellow gold & diamond set, flexible link pendant/necklet.

Feature; "drop style" pendant/necklet. Comprising, a raised, four claw set, houses one round brilliant cut diamond, claw set. Suspended from a fine curb linked chain, with a bolt ring clasp attached.

Polished finish, stamped "375 CMF" - acid tested as 9 carat gold.

Necklet/chain dimensions = 45.00cm (length) x 1.71mm (width) x 0.87mm (depth).

The necklet/pendant contains:

One claw set round brilliant cut diamond, clarity is "Si", colour is "light brown tint", medium cut quality.

Dimensions = 4.20mm (average diameter) x 2.56mm (D-estimated)

Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 4.19 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 4.13 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond would require removal from the setting. The below replacement figure is based upon crafting a similar necklet/pendant employing similar materials and techniques being for a retail insurance purpose only.
