Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.13mm width (at base) x 0.82mm depth, with open back settings, and a curved underrail.

Feature white gold round top plate, housing eleven round brilliant cut diamonds, varying in size, largest to the centre, claw set. The top plate is secured to the underrail, and in between the extended shoulders of the plain and polished yellow gold band.

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

Ring size: N.

The ring contains:

Six claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 2.83mm(Dia) x 1.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.14mm(Dia) x 1.92mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.52ct (estimated - see NOTE below)

Twenty Two claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.73mm(Dia) x 1.06mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.48ct (estimated - see NOTE below)

Total Item Weight = 3.48 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 3.28 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
