## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 14ct yellow gold, gem set, multistone ring, of cast construction.

Plain, wide, low half round band of 6.09mm width (at base) x 1.06mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature rectangle top plate that has been secured to the underrail, and in between the tapering shoulders, of the plain and polished band. The top plate and shoulders have been embellished with one hundred and sixty-one round brilliant cut diamonds, claw set. The diamonds graduate in size, largest to the centre, all claw set.



Polished finish.

Stamped '14K michael hill 4.95TDW' - acid tested as 14 carat gold.

Ring size: U.

The ring contains:

One Hundred And Sixty One claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.60mm(Dia) x 1.59mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 4.95ct (estimated - see NOTE below)

Total Item Weight = 13.82 grams Total Gemstone Weight = 4.95ct Total Metal Weight = 12.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
