Valuation for Traditional Retail Insurance Replacement

Item 1

One, platinum, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, half round band of 2.55mm width (at base) x 1.33mm depth, with a curved underrail.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped 'PLAT ANTON' - acid tested as platinum.

Ring size: M 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs2", colour is "I".

Dimensions = 6.79mm(L) x 6.73mm(W) x 4.13mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 1.15ct (known weight - see NOTE below)

Total Item Weight = 4.30 grams

Total Gemstone Weight = 1.15ct

Total Metal Weight = 4.07 grams (estimated)



NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 2178711994 Dated: June 8, 2014. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2178711994. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
