Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, 'cluster', gem set, dress style ring, of cast construction.

Plain, narrow, tapered band of 1.74mm in width (at base) x 0.96mm depth, with a curved and split underrail.

Feature multi-claw ring design, consisting of a central four claw setting, housing one oval brilliant cut diamond, claw set. The setting and shoulders having eighty round brilliant cut diamonds, tapering in size, all claw set.

Polished finish - stamped 'Rx Au750 D1.00ct' - acid tested as 1.00 carat gold. Finger size to M.

The ring contains:

One claw set oval brilliant cut diamond, clarity 'Vs', colour 'G'.

Dimensions = 4.57mm(L) x 3.07mm(W) x 2.30mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)

Eighty claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to I' (mixed).

Dimensions = 0.80mm to 1.20mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 2.42 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 2.22 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
