### Valuation for Traditional Retail Insurance Replacement

One, hand assembled, necklet.

Fabricated from 22 carat yellow gold.

Of a diamond cut, elongated four sided linkage, alternating with a six ball and wire design.

Linkage of hollow construction.

Small Asian style 'S' style clasp attached.

Belcher link style end link sections.

Polished finish.

Not stamped - acid tested as 22 carat gold.

Necklet dimensions = 60.00cm (length) x 3.05mm (width).

Total Item Weight = 23.48 grams.

NOTE: This piece is believed to be of Asian manufacture and would be extremely difficult to replicate in Australia. The replacement figure is therefore based upon procuring from overseas a similar piece, allowing for precious metal content and minimum hours of manufacture.
