Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 3.02mm width (at base) x 1.14mm depth, with a curved underrail.

Feature 'cluster' style ring, with a central four claw setting, housing one square synthetic sapphire, claw set. Surrounding is two rows, housing a total of fifty-nine tapered baguette cut cubic zirconias, graduating in size, claw set. The settings are secured to the underrail, and in between the 'split' style shoulders, of the plain and polished band.

Polished finish.

Stamped '585 10.21' - acid tested as 14 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set square synthetic sapphire, colour is "blue".

Dimensions = 5.96mm(L) x 5.94mm(W) x 3.71mm(D-estimated)

Total Weight = 1.09ct (estimated - see NOTE below)

Fifty Nine claw set tapered baguette cut synthetic cubic zirconias, colour is "colourless".

Dimensions = 3.00mm(L) x 1.40mm(W) x 0.85mm(D-estimated) (smallest)

Dimensions = 6.00mm(L) x 1.60mm(W) x 0.98mm(D-estimated) (largest)

Total Weight = 5.90ct (estimated - see NOTE below)

Total Item Weight = 11.48 grams Total Gemstone Weight = 6.99ct Total Metal Weight = 10.08 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
