Valuation for Traditional Retail Insurance Replacement

Item 1

One, platinum, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round band of 2.07mm width (at base) x 0.82mm depth, with open back settings, and a curved underrail.

Feature central four claw setting, housing one semi-round cultured pearl, claw set. Either side of the central setting, is one four claw setting, each housing one round brilliant cut diamond, claw set. The settings are secured to the underrail, and in between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped 'Pd 900 002' - acid tested as platinum.

Ring size: O.

The ring contains:

One claw set semi-round cultured pearl, colour is "white".

Dimensions = 8.25mm(L) x 8.23mm(W) x 8.19mm(D)

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "H".

Dimensions (average) = 1.43mm(Dia) x 0.87mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.02 (estimated - see NOTE below)

Total Item Weight = 4.23 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
