Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold and 18ct rose gold, gem set, flexible link necklet, of hand-assembled construction.

Feature central bezel setting, housing one round brilliant cut diamond, bezel set. The centre-piece is joined one both sides to an articulated curved style linkage chain. The chain is alternating white gold, yellow gold, and rose gold links. The necklet has been finished with 'box' style clasp, with a figure 8 safety catch.

Necklet dimensions = 44.00cm (length including clasp) x 7.88mm (max. width).

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

The necklet contains:

One bezel set round brilliant cut diamond, clarity is "Si1", colour is "H".
Dimensions = 4.20mm(L) x 4.18mm(W) x 2.35mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 25.00 grams
Total Gemstone Weight = 0.26ct
Total Metal Weight = 24.95 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
