Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, flexible link necklet, of hand-assembled construction.

Feature 'fringe' drop style necklet. There are a total of sixteen lengths of of a 'woven' style chain, to the centre, held together by three losenge shaped settings. Each of the settings houses six round brilliant cut diamonds, bead set. The centre-piece is joined on both sides to four lengths of a 'woven' style chain. The necklet is finished with a 'box' style clasp, and a figure 8 safety catch.

Necklet dimensions = 54.50cm (length) x 4.10mm (width) x 1.07mm (depth).

Centre-piece dimensions = 83.00mm (drop length) x 19.77mm (width) x 4.08mm (depth).

Polished finish.

Stamped '750 ANTON' - acid tested as 18 carat gold.

The ring contains:

Eighteen bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G".
Dimensions (average) = 2.30mm(Dia) x 1.40mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.81ct (estimated - see NOTE below)

Total Item Weight = 28.73 grams

Total Gemstone Weight = 0.81ct

Total Metal Weight = 28.57 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
