Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 14ct white gold, gem set, hinged 'hoop' style earrings, of hand-assembled construction.

Feature one central row of larger, eight round brilliant cut diamonds, graduating in size, and two outer rows of smaller, nine round brilliant cut diamonds, all claw set. The earrings are finished with post and clip attachments.

Earring dimensions = 16.6mm (ave. length) x 7.64mm (ave. width) x 2.92mm (ave. depth).

Polished finish.

Unstamped - acid tested as 14 carat gold.

The earrings contain:

Sixteen claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 2.25mm(Dia) x 1.37mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.80ct (estimated - see NOTE below)

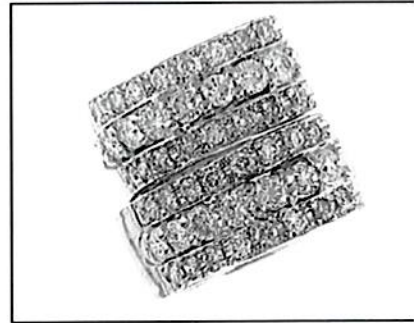
Thirty Six claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.70ct (estimated - see NOTE below)

Total Item Weight = 6.30 grams Total Gemstone Weight = 1.50ct Total Metal Weight = 6.00 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
