Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, diamond set ring, of cast construction.

Plain, wide, tapered band of 7.08mm at top to 3.70mm in width (at base) x 0.89mm depth, with open back settings.

Feature single row spanning across the top of the plain and polished band. The row houses five round brilliant cut diamonds, largest to the centre, tapering in size, channel set.

Polished finish.

Stamped '18K 750' - acid tested as 18 carat gold.

Finger size is Z.

The ring contains:

Five channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).

Dimensions = 3.20mm(Dia) x 1.98mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.95mm(Dia) x 2.40mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.75ct (estimated - see NOTE below)

Total Item Weight = 8.79 grams

Total Gemstone Weight = 0.75ct

Total Metal Weight = 8.64 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
