Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 14ct white gold & diamond set, solitaire ring.

Plain, narrow, low half round, tapered band, measures 1.58mm width (at base) x 0.97mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised, v-shaped six claw coronet setting, houses one round brilliant cut diamond, claw set. The extended shoulders, of the plain band tapers up wide to the top, from both sides.

Polished finish, stamped "14K" - acid tested as 14 carat gold.

Finger size = N.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "H", medium cut quality.
Dimensions = 6.10mm (average diameter) x 4.00mm (D-estimated) x 4%(Girdle Thickness)
Total Weight = 0.94ct (estimated - see NOTE below).

Total Item Weight = 4.12 grams, Total Gemstone Weight = 0.94ct, Total Metal Weight = 3.93 grams (estimated)

NOTE: There is a crack in the inside shoulder, & a chip in the girdle of the stone. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
