Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, pendant, of cast construction.

Feature one diagonal row of three, four claw settings, each housing one round brilliant cut diamond, claw set. The settings are secured between two extended and tapered wires, in a 'wrap around' style. There is a hidden bail, to the top of the pendant. Rhodium plating to the setting areas.

Pendant dimensions = 24.67mm (av. length) x 8.27mm (ave. width) x 5.56mm (ave. depth).

Polished finish.

Stamped '1/2 TW C 9K unknown symbol' - acid tested as 9 carat gold.

The pendant contains:

Three claw set round brilliant cut diamonds, clarity is "Si1", colour is "H to I" (mixed).

Dimensions = 3.44mm(Dia) x 2.10mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.03 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 1.93 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
