One necklet.

Fabricated from 14 carat yellow and white gold.

Of a decorative two tone alternating style linkage design.

Linkage of hollow construction.

Small 'half parrot' style clasp attached.

Bell style end link sections.

The two tone cross having a raised section, with small ring to the centre top. The bail being of an elongated tapering design.

Polished finish.

Stamped '2.46 585 & illegible stamp'.

Acid tested as 14 carat gold.

Necklet dimensions = 56.50cm (length including clasp) x 6.50mm (ave. width).

Pendant dimensions = 24.50mm (length including clasp) x 22.30mm (max. width).

Total Item Weight = 54.05 grams.
