Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 1.87mm in width (at base) x 0.97mm depth, with open back (cut-out) centre and shoulder settings.

Feature 'box' style setting, with pierced 'scroll' style sides, housing four Princess cut diamonds, invisible set. The setting is secured between the 'ramp' style shoulders of the plain and polished band. Each shoulder having four Princess cut diamonds, tapering in size, channel set.

Polished finish - stamped '18K 750 MHJ' - acid tested as 18 carat gold. Finger size is M.

The ring contains:

Four invisible set Princess cut diamonds, clarity 'P1', colour 'H'.
Dimensions = 2.95mm(L) x 2.95mm(W) x 1.85mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.52ct (estimated - see NOTE below)

Eight channel set Princess cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed).
Dimensions = 2.05mm(L) x 2.00mm(W) x 1.20mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 2.62mm(L) x 2.60mm(W) x 1.60mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.48ct (estimated - see NOTE below)

Total Item Weight = 4.30 grams - Total Gemstone Weight = 1.00ct - Total Metal Weight = 4.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. One centre diamond is damaged to two sides. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
