Valuation For Traditional Insurance Replacement Purposes

Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, narrow, low half round, tapered band of 1.53mm in width (at base) x 1.29mm depth, with curved underrail, and open back shoulder settings.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounded by a round-shaped frame, consisting of sixteen round brilliant cut diamonds, claw set. The setting base being of a four 'fine' claw design. To each extended shoulder of the plain and polished band is seven round brilliant cut diamonds, also claw set.



Polished finish - stamped '750 18K' - acid tested as 18 carat gold. Finger size is N.

The ring contains:

One claw set round brilliant cut diamond, clarity 'Si1', colour 'brown tint', medium cut quality. Dimensions = 4.15mm(Dia) x 2.50mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.26ct (estimated - see NOTE below)

Thirty claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to I' (mixed). Dimensions (average) = 1.30mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 3.50 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 3.40 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
