16 x Diamonds – round brilliant cut, 1.5mm to 1.6mm, estimated weight 0.015ct each, Clarity SI-P1, Colour H-I.

24 x Diamonds – baguette cut, 2.9mm to 1.8mm in length, estimated averaged weight 0.02ct each, Clarity SI, Colour G-H.
