Diamonds are rhodium plate grain channel set in central rows with rhodium plate bead set diamonds set along the outer rows. Set in a cross over design. The band is flat and flared, measures 2.6mm to 12.7mm in width. Cast manufacture. Ring Size: M1/2.

- 7 x Diamonds – round brilliant cut, 1.8mm to 1.9mm, estimated weight 0.025ct each, Clarity P1-P2, Colour K-M.
- 80 x Diamonds – single cut, 0.9mm to 1.2mm, estimated weight 0.005ct each, Clarity SI-P2, Colour K-M.

Due to the stones being set the weight, clarity and colour are estimated.
