Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.58mm width (at base) x 1.19mm depth.

Feature central vertical row housing, one emerald cut diamond, one round brilliant cut diamond, and one Princess cut diamond, all claw set. The settings are secured between the shoulders of the plain and polished band.

Polished finish. Stamped '750' - acid tested as 18 carat gold. Ring size: N.

The ring contains:

One claw set emerald cut diamond, clarity is "Vs", colour is "I".

Dimensions = 4.16mm(L) x 3.21mm(W) x 2.28mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

One claw set round brilliant cut diamond, clarity is "Vs", colour is "H".

Dimensions = 4.63mm(Dia) x 2.93mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.37ct (estimated - see NOTE below)

One claw set princess cut diamond, clarity is "Si1", colour is "H".

Dimensions = 3.80mm(L) x 3.66mm(W) x 2.60mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 4.99 grams Total Gemstone Weight = 0.87ct Total Metal Weight = 4.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
