Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold and 14ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.46mm width (at base) x 1.29mm depth.

Feature central white gold four claw setting, housing one oval shaped diamond, claw set. The setting is secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '14K michael hill 542221962' - acid tested as 14 carat gold.

Ring size: J 1/2.

The ring contains:

One claw set oval shaped diamond, clarity is "P1", colour is "G".

Dimensions = 6.05mm(L) x 4.51mm(W) x 2.75mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.02 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 1.92 grams (estimated)

NOTE: The diamond has been accompanied with an IGI report of authenticity Report number 542221962. The diamond has also been laser inscribed upon the girdle with michael hill and IGI (logo) and 542221962. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
