Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, flexible link necklet, of hand-assembled construction.

Feature open six point 'star' type pendant, with a central round brilliant cut diamond, claw set. The surrounding 'star' houses a total of twenty-four round brilliant cut diamonds, claw set. The pendant has been finished with an articulated tapered bail. The pendant has been suspended from 'woven' style chain, that has a filed design, and has been finished with a small 'bolt' style clasp.

Chain dimensions = 46.00cm (ave. length) x 0.83mm (ave. width).

Pendant dimensions = 16.00mm (ave. length) x 8.98mm (ave. width) x 2.18mm (ave. depth).

Polished finish.

Stamped 'Au750 ITALY L 750' - acid tested as 18 carat gold.

The necklet contains:

One claw set round brilliant cut diamond, clarity is "Vs", colour is "G".

Dimensions = 3.70mm(Dia) x 2.26mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Twenty Four claw set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions (average) = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.12ct (estimated - see NOTE below)

Total Item Weight = 2.87 grams Total Gemstone Weight = 0.30ct Total Metal Weight = 2.81 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
