Valuation for Traditional Retail Replacement

Item 1

One, lady's, raised 9ct white gold and diamond set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures 2.19mm width (at base) x 1.31mm depth, with cut-out underrail, open back settings, underneath.

Feature "solitaire style" ring design, with shoulder stones. Comprising, raised four claw setting, housing one round brilliant cut diamond claw set. Secured between the extended shoulders, of the band, both sides taper up and split to the side of the setting. Each contains, fourteen round brilliant cut diamonds, pave bead set. Polished finish, stamped "375 JP21" - acid tested as 9 carat gold. Finger size = L1/2.



The ring contains;

One claw set round brilliant cut diamond, clarity is "Si2", colour is "H", medium cut quality.
Dimensions = 3.90mm (Diameter) x 2.60mm (D-estimated) x 6%(Girdle Thickness)
Total Weight = 0.25ct (estimated - see NOTE below).

Twenty Eight pave bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.03mm (average diameter) x 0.63mm (D-estimated) (smallest)
Dimensions = 1.27mm (average diameter) x 0.77mm (D-estimated) (largest)
Total Weight = 0.15ct (estimated - see NOTE below).

Total Item Weight = 2.10 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 2.02 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
