Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of hand-assembled, 10ct yellow gold, diamond set, 'stud' style earrings.

Feature 'stud' style earring design, each consisting of a four claw double railed setting, claw set with one round brilliant cut diamond.

Post and butterfly fittings attached.

Polished finish.

Stamped 'FT 10K' - acid tested as approximately 10 carat gold.

Post and butterfly fittings attached.

Earring dimensions = 4.18mm (width) x 3.94mm (depth).

The earrings contain:

Two claw set round brilliant cut diamonds, clarity 'P2 & P3' (mixed), colour 'yellow tint'.

Dimensions = 4.10mm(Dia) x 2.50mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 4.18mm(Dia) x 2.55mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.52ct (estimated - see NOTE below)

Total Item Weight = 0.50 grams

Total Gemstone Weight = 0.52ct

Total Metal Weight = 0.40 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
