Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 14ct yellow gold and 14ct white gold, cluster style, gem set, dress ring.

Plain, narrow, tapered band of 1.96mm in width (at base) x 1.48mm depth, with curved underrail.

Feature white gold petal style, cluster setting, housing one round brilliant cut diamond, secured in four claws to the centre. Surrounded by ten round brilliant cut diamonds, rub-over set. Secured between the extended and plaited shoulders of the yellow gold plain and polished band.

Polished finish - stamped '14K .50 5737737' - acid tested as 14 carat gold. Finger size is J 1/2.

The ring contains:

One claw set early brilliant cut diamond, clarity 'Si', colour T.

Dimensions = 4.20mm(Dia) x 2.65mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.28ct (estimated - see NOTE below)

Ten rub over set round brilliant cut diamonds, clarity 'Si', colour 'G to H' (mixed).

Dimensions (average) = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 3.22 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 3.12 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
