### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, lady's hand-assembled raised, 18ct white gold & diamond set, flexible link necklet.

Feature: "single row style with alternating drops". Comprising, 132 rub-over setting to front, open back underneath, houses one hundred & thirty two round brilliant cut diamonds, rub-over set. Running to back each side forty double chinere style flexible links secured with a box clasp closure, to one side fitted with a figure 8 safety clip.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Necklet dimensions = 42.50cm (total length inclusive) x 2.70mm (width) x 3.00mm (depth).

The necklet contains:

One Hundred And Thirty Two rub over set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (smallest)

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (largest)

Total Weight = 2.00ct (estimated - see NOTE below).

Total Item Weight = 26.80 grams, Total Gemstone Weight = 2.00ct, Total Metal Weight = 26.40 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
