Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's 2pce, 9ct yellow gold & diamond ring set.
Plain, narrow, low half round, tapered band, a combined basal width 4.42mm x 0.98mm depth, with curved underrails.

Feature, "2pce ring set" Comprising, a illusion set solitaire engagement ring & channel set band. Housing four Princess cut diamonds, grouped together, illusion claw set, in a rhodium plated setting to highlight. The extended shoulders, of the plain band taper up wide to the top, from both sides. The wedding band contains ten Princess cut diamonds, channel set across the top.

Polished finish, stamped "375, GM16, 375, GM16" - acid tested as 9 carat gold. Finger size = S.

The ring set contains;

Four illusion claw set Princess cut diamonds, clarity is "Vs & Si"(mixed), colour is "J to K"(mixed), medium cut quality.
Average dimensions = 3.29mm (L) x 3.29mm (W) x 1.97mm (D-estimated)
Total Weight = 0.70ct (estimated - see NOTE below).

Ten channel set Princess cut diamonds, clarity is "Si", colour is "J to K"(mixed), medium cut quality.
Average dimensions = 1.80mm (L) x 1.80mm (W) x 1.28mm (D-estimated)
Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 5.97 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 5.77 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
