Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand finished, raised 18ct white gold & gemset, solitaire ring. Plain, narrow, low half round, tapered band, measures 2.57mm width (at base) x 0.95mm depth, with curved underrail.

Feature; "solitaire style" dress ring,. Comprising, a raised six claw setting houses one oval-shaped, faceted, garnet (rhodolite type), claw set. The extended shoulders, of the band taper up to pointed end terminations, from both sides.

Polished finish, stamped "18ct" - acid tested as 18 carat gold.

Finger size = N1/2.

The ring contain;

One claw set oval-shaped, faceted, garnet (rhodolite type), colour is "dark reddish violet".

Dimensions = 9.04mm (L) x 7.00mm (W) x 4.27mm (D-estimated)

Total Weight = 2.11ct (estimated - see NOTE below).

Total Item Weight = 3.52 grams, Total Gemstone Weight = 2.11ct, Total Metal Weight = 3.10 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
