## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, hand-assembled, 9ct yellow gold, gem set bracelet.

Feature 'padlock' style bracelet, consisting of a 'floral' filigree style padlock, having one heart-shape natural amethyst, rub-over set.

The bracelet of a hollow 'belcher' style, of an alternating patterned and plain design, with 'ring' style end linkages.

Safety chain fitted.

Polished finish - stamped '9CT JP146' (on padlock), '9ct' (on bracelet) - acid tested as 9 carat gold.

Bracelet dimensions = 20.00cm (length including end linkages) x 7.37mm (ave. diameter) x 3.03mm (ave. width).

The bracelet contains:

One rub over set mixed cut heart-shape natural amethyst, colour 'medium dark purple'.

Dimensions = 5.10mm(L) x 4.84mm(W) x 2.95mm(D-estimated)

Total Weight = 0.34ct (estimated - see NOTE below)

Total Item Weight = 14.12 grams - Total Gemstone Weight = 0.34ct - Total Metal Weight = 14.05 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar bracelet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
