Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, 'three stone' style ring, of cast construction.

Plain, narrow, low half round band of 3.05mm width (at base) x 1.16mm depth, with open back settings.

Feature central bezel setting, housing one emerald cut natural sapphire, bezel set. Either side of the central setting, is one bezel setting, each having one round brilliant cut diamond, claw set. The settings are secured between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '18K' - acid tested as 18 carat gold.

Ring size: P.

The ring contains:

One bezel set emerald cut natural sapphire, colour is 'blue'.

Dimensions = 6.00mm(L) x 4.00mm(W) x 2.43mm(D-estimated)

Total Weight = 0.58ct (estimated - see NOTE below)

Two bezel set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 4.58 grams Total Gemstone Weight = 0.64ct Total Metal Weight = 4.45 grams (estimated)

NOTE: The sapphire has some abrasion and chips to the crown facets. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
