Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow, low half round band of 2.12mm width (at base) x 1.48mm depth, with a curved underrail.

Feature central four claw setting, housing one Princess cut diamond, claw set. The setting is secured to the underrail, and in between the extended and square shoulders, of the plain and polished band. Rhodium plating to the central setting.

Polished finish.

Stamped '375 M' - acid tested as 9 carat gold.

Ring size: N 3/4.

The ring contains:

One claw set Princess cut diamond, clarity is "Si2", colour is "H".

Dimensions = 3.19mm(L) x 3.16mm(W) x 2.20mm(D-estimated) x 1%(Girdle Thickness)

Total Weight = 0.19ct (estimated - see NOTE below)

Total Item Weight = 2.27 grams

Total Gemstone Weight = 0.19ct

Total Metal Weight = 2.23 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
