### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.76mm width (at base) x 1.20mm depth, with open back settings, and a curved underrail.

Feature central white gold square top plate, within a four claw setting, housing four Princess cut diamonds, invisibly set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished yellow gold band. Each of the shoulders houses one row of five Princess cut diamonds, channel set.

Polished finish.

Stamped '750 JP88' - acid tested as 18 carat gold.

Ring size: N 1/2.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 3.00mm(L) x 3.00mm(W) x 2.13mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.60ct (estimated - see NOTE below)

Ten channel set Princess cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to J" (mixed).

Dimensions (average) = 2.00mm(L) x 2.00mm(W) x 1.42mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 5.16 grams Total Gemstone Weight = 1.10ct Total Metal Weight = 4.94 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
