Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct rose gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.17mm width (at base) x 1.36mm depth, with open back settings, and a decorative curved underrail.

Feature cushion shaped top plate housing nine round brilliant cut diamonds, to the centre, claw set. The surround and shoulders, house a total of sixty-eight round brilliant cut diamonds, varying in size, claw set. The top plate is secured to the 'split' style shoulders of the plain and polished band.

Polished finish.

Stamped '10K 0.50 michael hill' - acid tested as approximately 10 carat gold.

Ring size: R 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1 & P2" (mixed), colour is "H".

Dimensions = 3.30mm(Dia) x 2.01mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.05ct (estimated - see NOTE below)

Seventy Six claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.45ct (estimated - see NOTE below)

Total Item Weight = 3.78gm Total Gemstone Weight = 0.50ct Total Metal Weight = 3.68 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
