Large 'parrot' style clasp attached.

Paddle style end link sections.

Polished finish.

Stamped '417 MHJ NZ' (on chain), '10K' (on clasp).

Acid tested as approximately 10 carat gold.

Chain dimensions = 56.64cm (length including clasp) x 6.80mm (ave. width).

Total Item Weight = 56.64 grams.
