A platinum, stamped plat five diamond ring.

The central diamond is eight claw collet set with a diamond six claw collet set either side. A diamond is bead set in each leaf design upraised shoulders.

Measurements

1 x Diamond - Early modern brilliant cut - 7.10mm x 7.20mm x 4.27mm, estimated weight 1.33ct. Clarity P1, Colour C2 Champagne, contains surface reaching inclusions and a chip.

1 x Diamond - Early modern brilliant cut, 4.49mm x 4.49mm x 3.10mm, estimated weight 0.38ct, Clarity P1, Colour M, contains surface reaching inclusions.

1 x Diamond - Early modern brilliant cut, 4.60mm x 4.60mm x 3.10mm, estimated weight 0.40ct, Clarity P1, Colour K, contains surface reaching inclusions.

2 x Diamonds - Single cut, 1.6mm, estimated weight 0.015ct each, Clarity VS, Colour J-L.
