## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 10ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 1.52mm width (at base) x 1.10mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature round top plate, housing seven round brilliant cut diamonds, to the centre, claw set. The surround and shoulders house a total of sixty-seven round brilliant and single cut diamnds, varying in size, and claw set. The top plate is secured between the tapering shoulders, of the plain and polished band.



Polished finish.

Stamped '10K 0.50 michael hill' - acid tested as approximately 10 carat gold.

Ring size: N 1/2.

The ring contains:

Eleven claw set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.90mm(Dia) x 1.16mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.24ct (estimated - see NOTE below)

Sixty Three claw set single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.00mm (diameter) (smallest)

Dimensions = 1.20mm (diameter) (largest)

Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 2.82 gramsTotal Gemstone Weight = 0.50ct Total Metal Weight = 2.72 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
